## **Acrymax Roof Coating - Material Warranty**

An *Acrymax Roof Coating Material Warranty* warrants to the building owner that a properly applied Acrymax roof coating system will not leak water for a specified period of time, as the result of normal weathering or material manufacturing defects. The length of the warranty is determined by the type of roof that is coated and the specific Acrymax coating system that is used. If any portion of the warranted roof that has been coated with Acrymax coating products leaks as the result of defects in the Acrymax coating, Acrymax will provide sufficient Acrymax materials to repair those leaks. Decisions as to the extent of repair or replacement required will be made solely by Acrymax.

Obligations under the *Acrymax Roof Coating Material Warranty* are limited by the specific terms and conditions of the respective warranty. Sample warranties are available by e-mailing Acrymax at <u>warranty@acrymax.com</u> or by calling 800-553-0523. To qualify and obtain a warranty the following requirements must be met:

## **Roof Coating Material Warranty Requirements**

- 1. **Request for Project Acceptance** Detailed project information is required to be submitted prior to start of project. No warranty will be issued on projects that have not been pre-approved for warranty by Acrymax.
  - a. Acrymax Project Information Form
  - b. Initial Conditions Assessment
  - c. Roof Sketch
  - d. Digital picture documentation.
  - e. Adhesion test results
- 2. **Preparation Report** Confirmation of proper preparation. This information is required to be submitted with Request for Warranty.
  - a. Description of preparation methods used
  - b. Confirmation of tape test
  - c. Digital pictures before and after preparation
- 3. **Job Log** A job log must be kept during application of the roof coating system including the following information must be submitted with Request for Warranty Form at completion of application.
  - a. Dates of application including weather conditions
  - b. Digital photo documentation of installation including preparation, application, and final completion
- 4. **Request for Warranty Form** This form must be submitted within 30 days of the completion date of the roof coating project.

## **Conditions and Limitations**

The following conditions and limitations apply to the Acrymax Roof Coating Material Warranty. There are also additional conditions and limitations that are included in the warranty document.

Acrymax's sole responsibility under this limited material warranty is for defective material and Acrymax's only obligation shall be to either replace, or refund the purchase price of, the materials or part thereof proven to be defective. Acrymax's liability will under no circumstances exceed replacement of the product proven defective. Labor costs for installing repair or replacement materials are specifically excluded. Any replacement materials, as well as the original materials remaining, will be warranted only for the balance of the original warranty period.

Acrymax reserves the right to conduct inspections of any Acrymax roof coating project at any time prior to start of the installation of the roof coating system. If it determined at the sole discretion of Acrymax that any part of the roof to be coated is not in a suitable condition for installation of an Acrymax system no warranty shall be made available, unless or until any necessary unsuitable conditions are corrected. Acrymax also reserves the right to conduct inspections during installation and after final completion of the roof coating system. If in the sole judgment of Acrymax the coating system has not been applied according to Acrymax specifications no warranty shall be issued until the coating system has been brought into compliance with the specification. Any defects in the installation including failure to achieve minimum dry film thickness, failure to use reinforcement fabric as necessary, and any other defects in the installation as determined by Acrymax must be corrected to the satisfaction of Acrymax before warranty shall be issued.

Acrymax shall not be liable for any consequential, indirect, or incidental damages of any kind, including damage to the interior or exterior of the building. Mold growth that may occur as a result of any leaks in an Acrymax roof coating system is specifically excluded from coverage under any Acrymax warranty. This warranty give you specific legal rights, and you may have other rights which vary from state to state.
